For purposes of this calculation and to make things consistent, ratios have been computed for the 24/25 academic year including faculty counts and student census. Changes in the faculty and student census across the summer (and two academic years) do not substantially change these factors; we have a constant faculty census of approximately 150 total, with 65 FTE, and 240 students. Design studios are generally 10:1 or 11:1 students to faculty; occasionally those courses are taught in units of 12 if the students are working in pairs.

We continue to raise additional endowment funds to support financial aid, and have increased funded support to students from \$3 million in AY16-17 to \$9 million in AY24-25. Further, student employment salaries have increased by 30% since execution of the graduate student union contract. Approximately 50 positions are paid Teaching Fellows earhng \$5350 per term.

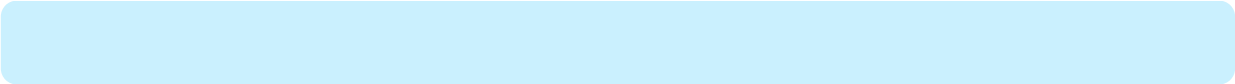

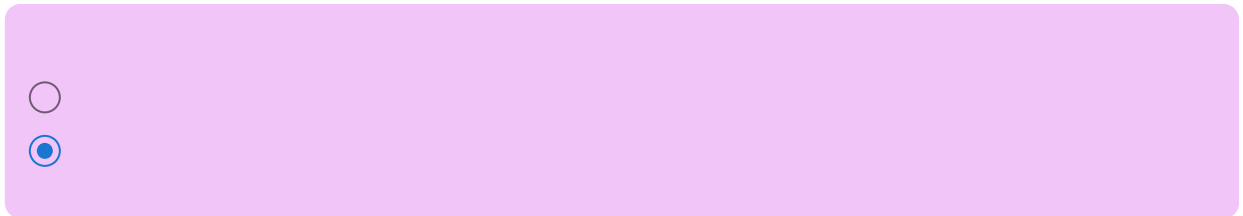

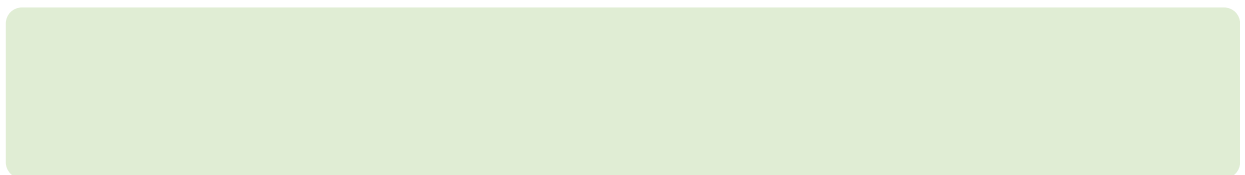
